**OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA AND PUERTO RICO, 18 YEARS AND OLDER (19 YEARS AND OLDER IN ALABAMA AND NEBRASKA).**

**The Promotion is no way sponsored, endorsed, administered by, or associated with X Corp., Meta Platforms Inc. TikTok, Inc. or Reddit, Inc. (herein "Social Platforms") None of these Social Platforms are affiliated with Mondelēz Global LLC ("Sponsor") in any way.**

This Promotion consists of an instant win game ("Instant Win Game") and a sweepstakes ("Sweepstakes") as described in these Official Rules. The Promotion begins at 12:00 am Eastern Time ("ET") on January 31, 2026 and ends at 11:59 pm ET on April 6, 2026 ("Promotion Period"). For purposes of this Promotion, each "Day" begins at 12:00 am ET and ends at 11:59 pm ET.

**1. HOW TO ENTER THE SWEEPSTAKES:** During the Promotion Period, first visit [www.TimeOutz4Snacks.com](http://www.TimeOutz4Snacks.com) ("Website") either directly or via a QR code on Promotion-related materials, and follow the links to submit your valid email address. The email address submitted must be:

- able to receive emails;
- personal to entrant and under entrant's sole control,
- private and not publicly accessible, and
- cannot be a "relay" alias or similar, i.e. one that forwards emails to your inbox, while masking your real email address.

Upon confirmation of your valid email address, you will receive an email with a link to register for the program (first visit only). You will be asked to select your preferred retailer from among a predetermined list. When logging in thereafter, you will only need to provide the email address you submitted upon registration.

Locate the UPC code on the Qualifying Product package and enter it in the designated field to receive 1 Sweepstakes entry.

**OR**

**2) Take a Product Survey:** To receive a Sweepstakes entry without making a purchase, respond to the 10 multiple choice survey questions presented. By completing and submitting the survey you will receive 1 Sweepstakes entry.

By completing 1 of either of the above actions (B 1 or B 2) you will also receive 1 Instant Win Game Play.

**2.
